## DISPOSITION: MOTION TO AMEND ORDER GRANTED

On June 19, 2007, AT&T Mobility LLC (AT&T Mobility)<sup>1</sup> filed a petition to amend Order No. 07-111. In that order, we included, as Appendix A, a list of wire centers for which AT&T Mobility has been designated as an eligible telecommunications carrier. At the time of filing, AT&T Mobility was unaware that Pioneer Telephone Cooperative renamed one of the identified wire centers from Chitwood (CHWDOR) to Eddyville (EDVLOR). AT&T Mobility contends that the listing of the wire centers in Appendix A should be amended to reflect the new name. The Commission Staff supports AT&T Mobility's request.

The petition is granted. Order No. 07-111, Appendix A, page 7 is amended to delete "Chitwood (CHWDOR)" and to replace the deletion with "Eddyville (EDVLOR)." The remainder of the order is unchanged.
