DISPOSITION: REQUEST GRANTED; ORDER NO. 07-276 AMENDED TO ALLOW WITHDRAWAL OF ARB 637(7)

On June 19, 2007, the Public Utility Commission of Oregon (Commission) approved negotiated agreements and amendments in three separate dockets, pursuant to Section 252(e) of the Telecommunications Act of 1996. *See* Order No. 07-276.

One of the approved amendments was the Seventh Amendment, Business Escalation Agreement (Agreement), to ARB 637, filed by Verizon Northwest Inc. and Qwest Corporation (Qwest). On July 19, 2007, Qwest filed a letter requesting the withdrawal of this Agreement that was approved in Order No. 07-276. Qwest stated that it

> "originally filed this Agreement on the basis of its understanding that the escalation procedures applied to the services provided under the interconnection agreements between the parties * * *. After such filing, however, it became evident that the intended scope of the Agreement was <u>not</u> to cover interconnection agreement services. The parties specifically acknowledge and agree that the agreement is not intended to amend any of the parties' existing interconnection agreements * * * Qwest respectfully withdraws the Business Escalation Agreement * * *."

No party filed an objection to Qwest's request.

Pursuant to ORS 756.568, the Commission may amend its Orders. Granting this motion would not affect any party's substantive rights or responsibilities under the underlying agreements. It is a correction to conform the Commission order to the actual decision intended and followed. Qwest's request is granted.

ORDER

IT IS ORDERED that:

- 1. Order No. 07-276 is hereby corrected by striking the language "ARB 637(7)."
- 2. The correction to Order No. 07-276 is hereby entered *nunc pro tunc* as of June 19, 2007, the date of the decision approving the amendment.
- 3. The Seventh Amendment filed on May 25, 2007, in docket ARB 637, is withdrawn.
- 4. The remainder of Order No. 07-276 is unchanged.
