On August 15, 2007, Northwest Natural Gas Company, dba NW Natural (NW Natural) requested reauthorization for deferral of costs related to its Bare Steel Replacement program from the Public Utility Commission of Oregon (Commission). The Bare Steel Replacement program was originally part of a safety program approved by the Commission in Order No. 01-843. The request, made pursuant to ORS 757.259, would extend the twelve-month deferral granted in Order No. 06-555, which is due to expire October 1, 2007. A full description of the filing and its procedural history are contained in the Staff Report, attached as Appendix A and incorporated by reference.

At its Public Meeting on October 9, 2007, the Commission adopted Staff's recommendations and approved NW Natural's current request.

ORDER

IT IS ORDERED that Northwest Natural Gas Company, dba NW Natural's application for reauthorization to defer Bare Steel Replacement program costs for a twelve-month period beginning October 1, 2007, is approved.

STAFF RECOMMENDATION:

Staff recommends the Commission approve Northwest Natural's request for reauthorization to defer costs relating to its Bare Steel Replacement program pursuant to ORS 757.259, for a twelve month period beginning October 1, 2007.

DISCUSSION:

On August 15, 2007, Northwest Natural (NWN or Company) requested reauthorization for deferral of costs related to its Bare Steel Replacement program pursuant to ORS 757.259. The Commission originally authorized the deferral of similar costs in 2001 in Commission Order No. 01-843 (Docket UM 1030). Last year, in its September 19, 2006, Public Meeting, the Commission approved reauthorization to defer costs related to this program for the twelve months beginning October 1, 2006, in Commission Order No. 06-555.

The Bare Steel Replacement Program was born out of a need for NWN to replace corrosion-subject steel in a timely manner due to concerns by PUC Safety Staff and the Company's concern about reliability. Following extensive negotiations by all parties, a signed Stipulation was accepted by the Commission in its regular public meeting on September 25, 2001, resulting in Commission Order No. 01-843.

Pursuant to the terms of the 2001 Stipulation, the Company is authorized to spend approximately \$3 million per year, up to a maximum of \$6 million per year, through

September 30, 2021, in what has been referred to as; "The Accelerated Bare Steel Replacement Program". The parties to the Stipulation agreed that any amounts spent in excess of \$6 million per year for Accelerated Bare Steel Replacement, would not be eligible for this program unless parties were to come to a new agreement.

For 2007, NWN has reported that they invested approximately \$3.2 million in Accelerated Bare Steel Replacement for the twelve-month period beginning October 1, 2006. Beginning October 1, 2007, NW Natural estimates it will spend approximately \$3 million in Accelerated Bare Steel Replacement.

NWN's Geo-hazard Risk Mitigation program was included in the past with the Bare Steel Replacement application; however, last year the Geo-hazard Risk Mitigation program bifurcated into a separate Stipulated Agreement which was adopted by Commission Order No. 06-554. For this reason, it will appear as a separate filing this year and is not included in this application.

Reason for Deferral

Adoption of this deferred account is authorized by 757.259(2)(d). The costs of the program are utility expenses, the recovery of which should be deferred in order to minimize the frequency of rate changes, and to match appropriately the cost borne by, and benefits received by, ratepayers. NW Natural has met the requirements of OAR 860-027-0300 in its filing.

Proposed Accounting

The proposed continued deferral will be recorded in a sub-account of account 186 (Miscellaneous Deferred Debits). In the absence of deferral approval, the company would record the amounts in the sub-account of FERC account 401 (Utility Operation Expense).

Staff has reviewed the Company's application and recommends the Commission approve NWN's request to reauthorize the deferral of its Accumulated Bare Steel Replacement Program costs.

PROPOSED COMMISSION MOTION:

The Commission approve Northwest Natural's request for reauthorization to defer costs relating to its Bare Steel Replacement Program pursuant to ORS 757.259, for a twelvemonth period beginning October 1, 2007.
