DISPOSITION: TARIFF SHEETS SUSPENDED

On February 27, 2008, PORTLAND GENERAL ELECTRIC COMPANY (PGE) filed tariff sheets in Advice No. 08-02 to be effective April 1, 2008. The terms of the proposed tariff sheets are set forth in the Staff Report dated March 10, 2008, attached as the Appendix to this order.

The Public Utility Commission of Oregon (Commission) initially docketed the filing as UE 197. The filing was later bifurcated into two dockets: UE 197, to address PGE's request for a general rate revision; and UE 198, to address PGE's request for a revision to its net variable power costs.

At its March 25, 2008, public meeting, the Public Utility Commission of Oregon found good and sufficient cause exists to investigate the propriety and reasonableness of the tariff sheets pursuant to ORS 757.210 and 757.215. The Commission ordered suspension of the advice pending the investigations in dockets UE 197 and UE 198.

IT IS ORDERED that Advice No. 08-02 filed by PORTLAND GENERAL ELECTRIC is suspended for a period of time not to exceed nine months from April 1, 2008, the effective date of the tariff sheets.

#### STAFF RECOMMENDATION:

I recommend that the Commission suspend Portland General Electric's application for revised tariff schedules in Advice No. 08-02.

### **DISCUSSION:**

On February 27, 2008, Portland General Electric (PGE) filed Advice No. 08-02, an application for revised tariff schedules. The filing has been docketed as UE 197. The tariffs would implement a general rate revision, increasing PGE's revenues by \$145.9 million, or 8.9 percent overall. The percentage increases by rate class are 9.5 percent for residential customers, 7.7 percent for small non-residential customers, 9.9 percent for large non-residential customers, and 2.4 percent for lighting and signal customers.

Staff recommends the Commission suspend the tariffs for investigation. Suspending the tariffs will allow the Commission to evaluate the reasonableness of the company's proposed rates. ORS 757.215(1) allows the Commission to suspend the proposed rates an additional three months if it finds the investigation will not be completed by the end of the initial six-month suspension period. Due to the size of the increase and the complexity of the case, Staff believes there is sufficient cause for the Commission to determine that the investigation cannot be completed within the initial suspension period, and the additional three-month suspension should be approved at this time.
