DISPOSITION: CHARGES ASSESSED

The Public Utility Commission of Oregon (Commission) has designated its files on the subject of this matter as the record in this case. Based on information contained in those files, the Commission makes the following:

FINDINGS OF FACT

ADVANCED TELEMANAGEMENT GROUP INC. is a telecommunications provider required to submit quarterly contribution worksheets and payments to the Commission for the Oregon Universal Service Fund (OUSF). *See* ORS 759.425, and OAR 860-032-0620.

ADVANCED TELEMANAGEMENT GROUP INC. failed to submit the quarterly contribution worksheet(s) and payment(s) by the due date(s) as set out in OAR 860-032-0620(3).

The Commission sent a Proposed Order to ADVANCED TELEMANAGEMENT GROUP INC. on March14, 2008. ADVANCED TELEMANAGEMENT GROUP INC. did not respond.

Pursuant to OAR 860-032-0620 and OAR 860-032-0630, the Commission has proposed ADVANCED TELEMANAGEMENT GROUP INC. owes the \$100 late statement fee for the third quarter of 2007.

Where applicable, the interest amount is calculated as of the date of this order. The interest will continue to accrue at 9 percent per annum until the Commission receives full contribution payment. Conclusions

ADVANCED TELEMANAGEMENT GROUP INC. failed to provide quarterly contribution worksheet(s) and payments required by law. The amount set forth above should be assessed, with the exception that the interest, where applicable, will continue to accrue at 9 percent per annum until the Commission receives full contribution payment.

ORDER

IT IS ORDERED that the above amounts are assessed against ADVANCED TELEMANAGEMENT GROUP INC. and are immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
