STAFF RECOMMENDATION:

I recommend Pacific Power & Light's application, docketed as UM 1430, be approved for accounting purposes only.

DISCUSSION:

Pacific Power & Light (PacifiCorp or company) filed this application pursuant to ORS 757.259 and OAR 860-027-0300. The company requests an accounting order to track and defer the costs associated with a Commission-selected independent evaluator (IE) for its 2009 solicitation process for new renewable resources (2009R RFP).

Under the bidding guidelines established in Docket No. UM 1182, Order No. 06-446 (RFP Order), PacifiCorp filed for approval to open a docket for its 2009R RFP which was docketed as UM 1429. Guideline No. 5 of the RFP Order requires an IE to provide third party oversight during an RFP process to ensure that all offers are treated fairly, and allows a utility to request deferred accounting to track the associated costs for later inclusion into rates, subject to a prudency review. By Order No. 09-181, the Commission selected Boston Pacific Company to serve as the IE for this docket.

As the company's last proposal, known as its 2008R-1 RFP,¹ includes such a provision, PacifiCorp's application for deferral stated that it expects the 2009R RFP to require successful bidders to submit a fee. This success fee would be used to cover the costs

of the IE, leaving only the net amount to be deferred. However, Order No. 09-272, by which the Commission approved the 2009R RFP, does not require a fee from a successful bidder or a bid fee for bids submitted in this docket that were previously submitted during the 2008R-1 RFP process. Staff expects the company will track all of the IE's costs associated with this docket, net of fees from new bidders, for the later inclusion into rates, subject to a prudency review.

During the deferral period, PacifiCorp proposes to record the deferred costs in Account 182.3, Other Regulatory Assets. The company estimates the cost of the IE at \$250,000, approximately half that estimated for its 2008R-1 RFP.

PacifiCorp has met the requirements of OAR 860-027-0300 for this filing.
