ORDER
Application for Deferral of Expenses Associated with an Increase in FERC Land Fees.

## DISPOSITION: APPLICATION WITHDRAWN; DOCKET CLOSED

On March 30, 2009, Portland General Electric Company (PGE) filed an application for Deferral of Expenses Associated with an Increase in Annual Land Use Fees imposed by the Federal Energy Regulatory Commission (FERC). In its filing, PGE stated that, in Docket No. RM09-6-000, FERC issued a decision increasing the fees for the use of linear rights-of-way on government land. PGE adds that, following that decision, FERC notified PGE that its annual fees for use of federal lands would be increasing approximately $\$ 1.2$ million annually over the previous level. PGE's request was docketed as UM 1425.

In addition to filing the request for deferral, PGE, along with other affected parties, appealed FERC's decision to increase the annual land use fees. Following various legal proceedings, the U.S. Court of Appeals (D.C. Circuit) granted an emergency stay of FERC's decision. FERC later issued revised "interim" Annual Land Use Fees bills to PGE and other affected parties, but reserved its ability to issue revised bills at the new and significantly higher rates under the challenged new fee schedule. It also advised the Court that it did not intend to file a motion to dissolve the Court's stay at that time, but reserved the right to do so in the future.

On December 10, 2009, PGE filed a motion to close this docket. After discussions with Commission Staff, PGE has decided to withdraw its application due to the uncertainty of if and when the FERC Land Use Fees increase for the 2009 federal fiscal year will be imposed, and if imposed, whether it will be retroactive. Thus, PGE would likely file, if it becomes necessary, under a different subsection of ORS 757.259.

## ORDER

IT IS ORDERED that Docket UM 1425 is closed.
