#### DISPOSITION: APPLICATION APPROVED

On August 3, 2011, AmeriStar Solar filed a request to waive the 12-month installation requirement under OAR 860-084-0210 for a proposed 5.6 kW Solar Photovoltaic (SPV) system. AmeriStar Solar requests to extend the current deadline from October 15, 2011 to January 15, 2012. A full description of the filing, its procedural history, and Staff's recommendation are contained in the Staff Report, attached as Appendix A and incorporated by reference.

At its Public Meeting on August 23, 2011, the Commission adopted Staff's recommendation to extend the installation deadline of the proposed SPV system until January 15, 2012.<sup>1</sup>

#### STAFF RECOMMENDATION:

Staff recommends the Commission grant the waiver request by AmeriStar Solar (AmeriStar) and extend the installation deadline of the proposed Solar Photovoltaic System (SPV system) to January 15, 2011.

#### **DISCUSSION:**

On August 3, 2011, AmeriStar submitted a request to waive the 12-month installation requirement under OAR 860-084-0210 for a proposed 5.6 kW SPV system to serve a residential building in Washington County, Oregon. AmeriStar's installation deadline expires October 15, 2011, and requests a 90 days extension to complete the installation.

Due to back injuries to Bill Boyk, owner-operator of AmeriStar, the installation of the proposed SPV system may not be completed within the 12-month installation requirement. Mr. Boyk submitted medical reports showing that his back injury occurred in May 2011 and again in August 2011. Mr. Boyk obtained the necessary permit to install the system at the proposed site from Washington County's Department of Land Use & Transportation on April 11, 2011. Further, Mr. Boyk provided documentation of out of pocket expenses for permitting, site preparation and for ordering some parts and components of the system.

Because AmeriStar is a small owner-operator company, work progress has stopped due to Mr. Boyk's back injury. Mr. Boyk, however, indicated that he will resume work after he recovers from his back injury and that he is willing to hire additional workers to assist him in the project. Mr. Boyk indicated that to complete the project within the 12-month installation requirement, he would have to assign all the remaining work to hired workers. AmeriStar's budget could not afford this solution. Rather, Mr. Boyk plans on curtailing his work share in the project while assigning a portion of the work to the helping workers to avoid recurrence of his injury and to complete the installation of the project. This solution is financially feasible and affordable. However, it will require modification of the original construction schedule. Hence, the waiver and extension request.

Staff agrees that Mr. Boyk demonstrated AmeriStar's commitment to install the project and that the possibility of not meeting the installation deadline is due to factors outside of Mr. Boyk's control. Additionally, Staff believes that small businesses frequently rely on the owner-operator model and usually have limited financial resources. Further, it appears that denying the waiver request at this stage of the project could place AmeriStar in a financially difficult position.

In his request, Mr. Boyk seeks an extension of 90 days to complete the project. OAR 860-084-0000(3) provides:

"The Commission may waive any of the rules contained in Division 084 for good cause."

Staff agrees that Mr. Boyk has shown good cause for waiver and extension. Staff believes that granting Mr. Boyk a 90-day extension should provide ample time to complete the project's installation. Accordingly, Staff recommends the installation deadline be extended to January 15, 2011.

#### **PROPOSED COMMISSION MOTION:**

AmeriStar's request for waiver be granted, and the installation deadline be extended to January 15, 2011.
