In the Matter of the Imposition of Annual Regulatory Fees Upon Telecommunications Utilities and Competitive Telecommunications Providers Operating Within the State of Oregon.

ORDER

DISPOSITION: FEE LEVEL SET FOR CALENDAR YEAR 2012

Under ORS 756.310, we determine that it is necessary to impose a fee on telecommunications utilities and competitive telecommunications providers of twenty-five hundredths of one percent (0.25 percent) of gross retail intrastate revenue during the Calendar Year 2012 in Oregon. These fees are necessary to defray the cost of performing duties imposed by law upon the Public Utility Commission of Oregon (Commission). The fees, as imposed by this order on Calendar Year 2012, are due on or before April 1, 2013.

At the Public Meeting on October 4, 2011, we adopted Staff's recommendation to impose a fee on telecommunications utilities and competitive telecommunications providers of twenty-five hundredths of one percent (0.25 percent). The Staff Report is attached as Appendix A and is incorporated by reference.

ORDER

IT IS ORDERED that telecommunications utilities and competitive telecommunications providers operating in Oregon must pay, to the Public Utility Commission of Oregon, a fee of twenty-five hundredths of one percent (0.25 percent) of gross retail intrastate revenues during the Calendar Year 2012 in Oregon. In no case shall such fee be less than \$100. Each telecommunications utility and competitive telecommunications provider must pay the fee on or before April 1, 2013.

STAFF RECOMMENDATION:


By November 1, 2011, the Commission issue an order to set the annual PUC fee at 0.25 percent as the percentage rate for annual fees due from telecommunications providers on April 1, 2013, in accordance with ORS 756.310.

DISCUSSION:

ORS 756.310(6) requires each telecommunications provider to pay up to 25 hundredths of one percent (0.25 percent) of its gross retail intrastate Oregon revenue or \$100, whichever is more, to the Commission. The Commission opened Docket No. UM 940 in 1999 to set the annual fee levels for telecommunications providers.

The Commission collected \$2.24 million in annual fees from telecommunications providers in 2009, \$1.28 million in 2010, and approximately \$1.19 million in 2011.² During this three-year period, intrastate retail revenues declined by ten percent. Staff is

² The reason for the dramatic decrease in revenues was the rate decrease. In 2009, the rate was .25 percent. In 2010, the rate was approximately .16 percent. In 2011, the rate was .15 percent.



¹ Telecommunications provider means a telecommunications utility or a competitive telecommunications provider as defined in ORS 759.005 (ORS 756.310(8)(c)). This definition excludes radio common carriers and telecommunications cooperatives with certificates issued only under ORS 759.025.

forecasting continuing declines in gross retail intrastate Oregon revenues due to ongoing line losses. Therefore, for revenues recorded in 2012, the Commission should return the rate to the 2009 level and assess the annual fee at the statutory maximum level of .25 percent. This assessment rate will provide estimated annual fees of \$1.88 million from telecommunications providers for 2012.

The Commission must issue an order to establish the percentage rate for the annual fee "not less than 60 days prior to the calendar year upon which the fee is based" (ORS 756.310(6)(a)). For revenues recorded during 2012, this provision means the fee level order must be issued by November 1, 2011.

Attached is a draft order for the Commission's consideration. It is based on the previous fee level orders for revenues recorded by telecommunications providers during 2001 through 2011 (for example, Order 10-420).

PROPOSED COMMISSION MOTION:

The annual gross revenue fee for telecommunications providers be set at the maximum level of 0.25 percent for calendar year 2012.
