### STAFF RECOMMENDATION:

Staff recommends the Commission grant Solwatt, LLC's request for a waiver of the OAR 860-084-0210(1) installation requirement and extend the installation deadline to July 1, 2012.

### **DISCUSSION:**

On April 1, 2011, PacifiCorp awarded Kent and Laura Madison, and Solwatt, LLC (collectively "Petitioners"), a capacity reservation to install a 360 kW Solar Photovoltaic (SPV) system. Pursuant to OAR 860-084-0210(1), the proposed SPV system must be installed on or before April 1, 2012. Upon near completion of the project, a dispute arose between PacifiCorp and Petitioners with respect to the primary voltage interconnection requirements under OAR 860-084-0130(2)(b). In Order No. 12-107, the Commission granted Solwatt's request to waive the voltage interconnection requirements.

PacifiCorp and Petitioners could not complete their respective remaining work in the project until the Commission's decision on the voltage interconnection requirements waiver request. Therefore, Petitioners ask the Commission to waive the 12-month

requirement under OAR 860-084-0210(1) and extend the deadline to July 1, 2012, to allow both parties to complete their respective work in the project.

OAR 860-084-0000(3) provides:

"The Commission may waive any of the rules contained in Division 084 for good cause."

Petitioners provided information of the significant work they performed to install the project within the 12-month deadline. In addition, Petitioners provided a description of the work remaining by each party to complete the project. The delay in not meeting the original deadline is largely due to the circumstances imposed by the primary voltage interconnection issue. PacifiCorp does not oppose the waiver request. Further, since PacifiCorp has worked with Petitioners to resolve the voltage interconnection requirements issue, both parties have demonstrated their commitment and willingness to complete the project. Petitioners provided a description of the remaining work to complete the project.

This request is being presented before the Commission after the expiration of the April 1, 2012, installation deadline. Staff's legal representative advised that the Commission has authority to grant such waiver under OAR 860-084-0000(3). Further, Staff notes that the Commission received Petitioners' request on March 8, 2012, which is before the expiration of the original deadline.

Based on this information, Staff agrees that Petitioners established good cause for the waiver and recommends approval.

### PROPOSED COMMISSION MOTION:

The request by Kent and Laura Madison, and Solwatt, LLC, to waive the 12-month installation requirement and to extend the deadline to July 1, 2012, be granted.
