ORDER

**DISPOSITION: CHARGES ASSESSED**

The Public Utility Commission of Oregon (Commission) has designated its files on the subject of this matter as the record in this case. Based on information contained in those files, the Commission makes the following:

**FINDINGS OF FACT**

GLOBALSTAR USA LLC is a telecommunications provider required to submit monthly Residential Service Protection Fund (RSPF) surcharge remittance reports and payments to the Commission. *See* OAR 860-033-0006.

GLOBALSTAR USA LLC failed to meet all or part of the requirements specified above by the due date(s) as follows: the December 2012 RSPF Surcharge Remittance Form was filed and payment submitted after the due date.

The Commission served a Notice of Proposed Assessment on GLOBALSTAR USA LLC on 2/14/2013. GLOBALSTAR USA LLC did not respond.

Pursuant to OAR 860-033-0006 and OAR 860-001-0050, the Commission finds that GLOBALSTAR USA LLC owes \$105.99 which may include any or all of the following charges: late payment penalties, interest (calculated to the date of this Order), and late report fee(s) for December 2012. Please note that specific amounts for each assessed charge are not included in this Order to protect the confidentiality of GLOBALSTAR USA LLC underlying records.

**Conclusions**

GLOBALSTAR USA LLC failed to meet its filing obligations required by law. The amount set forth above should be assessed.

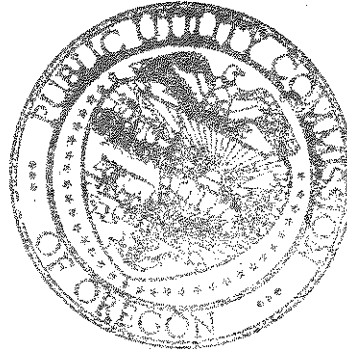
**ORDER**
