DISPOSITION: STIPULATION ADOPTED

In this order, the Public Utility Commission of Oregon adopts a stipulation between the Commission Staff and defendant and imposes civil monetary penalties under the terms and conditions of the stipulation.

I. COMPLAINT AND STIPULATION

On August 5, 2016, the Commission filed a complaint against defendant. The complaint charged defendant with four violations of law, two violations of OAR 952-001-0050(1) and two violations of OAR 952-001-0090(2), and requested a penalty of \$4,000. On August 5, 2016, a copy of the complaint was served.

On August 31, 2015, the parties in these proceedings entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, defendant:

(1) Admits committing the alleged violation and agrees that the Commission may enter an order assessing civil monetary penalties;

- (2) Agrees to complete, within 45 days following the entry of a final order, a training session with the Oregon Utility Notification Center Speakers Bureau on Oregon excavation laws and with Cascade Natural Gas on operator safety; and
- (3) To submit a completed Training Verification form(s) for all required trainings to the Commission within 10 days of the date of the last training and no later than 55 days following the entry of this order.

The parties further agree that a portion of the penalties should be suspended, unless defendant fails to comply with any provision of the stipulation or violates any rule adopted by the Oregon Utility Notification Center under ORS 757.552 for a period of one year following the date of the Commission's final order in these proceedings.

II. DISCUSSION

The stipulation is adopted. Under the terms of the stipulation, the allegations of the complaint are true, and defendant has violated the Oregon Administrative Rules as alleged. Under the provisions of ORS 757.993, penalties should be assessed against defendant under the terms and conditions of the stipulation.

III. ORDER

IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties are assessed against CHRISTIANSEN'S CONTRACTING COMPANY, LLC (An Oregon Limited Liability Company) in the amount of \$4,000 for four violations of law.
- 3. Defendant must pay the sum of \$800, due and payable within 30 days from the date of service of this order. The Commission acknowledges receipt of the amount of \$800 from defendant on September 1, 2016.

4. Defendant must:

- (a) Timely complete a training session with the Oregon Utility
 Notification Center Speakers Bureau. The Commission
 acknowledges that Defendant's employees that engage in
 excavation activity as a part of their job duties attended a training
 session on Oregon excavation laws on August 16, 2016;
- (b) Timely complete a training session with Cascade Natural Gas.

 Defendant will contact Cascade Natural Gas to arrange for, and ensure that all of Defendant's employees that engage in excavation

- activity or concrete work as a part of their job duties attend a training session on operator safety within 45 days of the entry of this order; and
- (c) File a completed Training Verification form(s) for all required training to the Public Utility Commission of Oregon at the address indicated on the form within 10 days of the date of the last training session and no later than 55 days of the entry of this order.
- 5. Payment of the balance of the penalties (\$3,200) will be suspended, unless defendant fails to comply with any term of the stipulation. If the defendant has not met the requirements and time periods set forth in paragraphs 3 and 4 above, the unpaid balance of the amount assessed in paragraph 2 will be due immediately following the expiration of the time periods.
