Application to be certified as an Electricity Service Supplier.

INTRODUCTION

On February 6, 2015, the Commission certified 3 Phases Renewables, LLC as an electricity service supplier (ESS or ES). *See*, Order 15-038. On September 15, 2016, 3 Phases Renewables Inc. filed a material change form with the Commission asking that it be granted scheduling ESS certification. This change was requested due to 3 Phases Renewables Inc. conversion from a California limited liability company to a California corporation under California Corporations Code Sections 17710.01, 1157, and 1150.

The Commission usually serves notice of an application by electronic mail to the Commission's ES application electronic mail list. As 3 Phases Renewables LLC was previously certified as a scheduling ESS, we waived our usual notice procedures.

Based on the application and the Commission's records, the Commission makes the following:

FINDINGS OF FACT

The Applicant, 3 Phases Renewables Inc. is a California corporation. Applicant intends to provide electricity service to nonresidential retail consumers in Oregon. Applicant seeks certification as a scheduling ES under OAR 860-038-0400 and ORS 757.649.

OPINION

Applicable Law

Applications to be certified as an electricity service supplier are filed pursuant to OAR 860-038-0400. OAR 860-038-0400(1) provides that:

An electricity service supplier (ESS) must be certified by the Commission to sell electricity services to consumers.

An applicant must declare whether it intends to offer electricity service as a scheduling or a nonscheduling electricity service supplier. OAR 860-038-0400(2) provides that:

An ESS must be certified as either a scheduling or nonscheduling ESS as prescribed in OAR 860-038-0410.

Applicant must comply with all other provisions as set forth in OAR 860-038-0400 including an attestation that Applicant will comply with all applicable laws, rules, Commission orders, and electric company tariffs.

CONCLUSIONS

Staff reviewed the material change request application and supporting documents. Applicant has met the requirements to be certified as an electricity service supplier. The material change request should be granted.

IT IS ORDERED that:

- 1. The application of 3 Phases Renewables Inc. to be certified as a scheduling electricity service supplier, is granted.
- 2. Applicant may provide authorized services in Oregon while maintaining an annual renewal date of February 6.
- 3. 3 Phases Renewables, LLC is no longer certified as an ESS.
