ORDER

DISPOSITION: CHARGES ASSESSED

The Public Utility Commission of Oregon (Commission) has designated its files on the subject of this matter as the record in this case. Based on information contained in those files, the Commission makes the following:

FINDINGS OF FACT

COREPACKET LLC is a telecommunications provider required to submit quarterly contribution worksheets and payments to the Commission for the Oregon Universal Service Fund (OUSF). *See* ORS 759.425, and OAR 860-100-0110.

COREPACKET LLC failed to meet all or part of the requirements specified above by the due date(s) as set out in OAR 860-100-0110(3).

The Commission sent a Proposed Order to COREPACKET LLC on May 2, 2017. COREPACKET LLC did not respond with full payment.

Pursuant to OAR 860-100-0110 and OAR 860-100-0120, the Commission has proposed COREPACKET LLC owes the current balance of \$100.00, which can include any or all of the following: contribution payment(s), late payment penalty(ies), interest and late statement fee(s), including any portion due but not paid for the period(s). These charges are for the fourth quarter of 2016.

Where applicable, the interest amount is calculated as of the date of this order. The interest will continue to accrue at 9 percent per annum until the Commission receives full contribution payment. Conclusions

COREPACKET LLC failed to meet its filing obligations required by law. The amount set forth above should be assessed, with the exception that any applicable interest will continue to accrue at 9 percent per annum until the Commission receives full contribution payment.

- 1. The above amounts are assessed against COREPACKET LLC and are immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
- 2. Where applicable, interest will continue to accrue at 9 percent per annum until the Commission receives full contribution payment.
