ORDER

#### DISPOSITION: CERTIFICATE OF AUTHORITY CANCELED

On February 2, 2007, Bigredwire.com, Inc. was granted a certificate of authority to provide telecommunications service in Oregon as a competitive provider. *See* Order No. 07-042.

Bigredwire.com, Inc. has failed to comply with Oregon Universal Service Fund (OUSF) requirements for 4<sup>th</sup> Quarter 2016 and 1<sup>st</sup> Quarter 2017 per ORS 759.425 and OAR 860-100-0100 through 860-100-0160.

Bigredwire.com, Inc. also failed to file a 2016 annual report as required by OAR 860-032-0060(2)(a), and failed to pay 2016 annual revenue fees as required by ORS 756.310 and OAR 860-032-0095.

Commission staff has made numerous attempts to notify Bigredwire.com, Inc. of the delinquencies and potential cancellation. Bigredwire.com, Inc. failed to respond, and cannot be reached through any of its official contact information.

ORS 756.515(4) provides that the Commission may, after investigation, but without hearing, make such findings and orders as deemed justified by the results of the investigation. In view of the foregoing, the Commission determined at its August 8, 2017, Public Meeting that Bigredwire.com, Inc. has failed to comply with Commission rules and terms of the certificate. The certificate of authority to provide telecommunications service should be canceled, per OAR 860-032-0008(2). Bigredwire.com, Inc. is reminded that because it had a certificate of authority for one or more days during 2017, it is required to file an annual fee statement and pay a minimum of \$100 for that year.

The Commission notes that this is the second time it has canceled a certificate held by Bigredwire.com, Inc. Before the Commission will process any future application for certification, Bigredwire.com, Inc.must fully comply with Commission rules. Any future application must include, as applicable:

- 1. An explanation of why the company was unable to comply with Commission rules;
- 2. Proof of payment of all outstanding revenue fees, including late payment fees, owed for each calendar year of operation pursuant to ORS 756.310(4)(a) and OAR 860-032-0095, in accordance with Commission requirements;
- 3. Proof of compliance with OUSF requirements pursuant to ORS 759.425 and OAR 860-100-0100 through 860-100-0160;
- 4. Proof of filing of any outstanding annual reports pursuant to OAR 860-032-0060; and
- 5. Proof of compliance with Residential Service Protection Fund (RSPF) requirements pursuant to ORS chapter 290, section 7, Oregon Laws 1987, and OAR 860-033-0006.

If Bigredwire.com, Inc. fails to include these items with its application, the Commission will deem the application incomplete.

IT IS ORDERED that the certificate of authority held by Bigredwire.com, Inc. is canceled.
