ORDER

DISPOSITION: CH

**CHARGES ASSESSED** 

In this order, the Public Utility Commission of Oregon assesses \$100.00 against WOODEN OWL COMMUNICATIONS LLC for failure to make required remittances. The Commission designates its files on the subject of this matter as the record in this case and makes the following:

#### FINDINGS OF FACT

WOODEN OWL COMMUNICATIONS LLC is a telecommunications provider required to submit monthly Residential Service Protection Fund (RSPF) surcharge remittance reports and payments to the Commission.<sup>1</sup> These amounts can include any or all of the following: RSPF surcharge remittance(s), late payment penalties, interest (calculated to the date of this Order), and late report fee(s) for November 2017<sup>2</sup>.

WOODEN OWL COMMUNICATIONS LLC failed to meet all or part of the requirements specified above by the due date(s) as follows: the November 2017 RSPF Surcharge Remittance Form was due on December 21, 2017, and has not been received.

The Commission served a Notice of Proposed Assessment on 1/11/2018 on 1/11/2018. WOODEN OWL COMMUNICATIONS LLC did not respond with full payment, and all current amounts owing have not been paid.

### **CONCLUSIONS**

WOODEN OWL COMMUNICATIONS LLC failed to meet its filing obligations required by law. WOODEN OWL COMMUNICATIONS LLC owes the current balance of \$100.00. These charges are for November 2017.

The amount set forth above should be assessed, with the applicable interest to accrue at 9 percent per annum until the Commission receives full payment.<sup>3</sup> Please note that specific amounts for each assessed charge are not included in this Order to protect the confidentiality of WOODEN OWL COMMUNICATIONS LLC underlying records. - 2. Where applicable, interest will continue to accrue at 9 percent per annum until the Commission receives full payment.
