DISPOSITION: PRICE PLAN IMPLEMENTATION EXTENDED; ORDER NO. 22-340 FURTHER AMENDED

On February 29, 2024, Lumen Technologies'<sup>1</sup> filed a request to extend the company's current price plan, which is currently set to expire on February 29, 2024.<sup>2</sup> Lumen states that it requires additional time to implement the terms of the stipulation adopted and modified by the Commission in Order No. 24-041<sup>3</sup> and requests that the Commission extend the price plan through May 15, 2024.

The Chief Administrative Law Judge has been delegated the authority to modify timelines specified in a Commission order.<sup>4</sup> Exercising that authority, I find good cause to further amend Order No. 22-340 to extend the original term of Lumen's price plan through May 15, 2024.
