Re: Northwest Industrial Gas Users' Request for Payment of 2007 Preauthorized Matching Grant, Cascade Account, Docket Nos. UG 173 & UM 1283

Honorable Judge Grant:

The Northwest Industrial Gas Users ("NWIGU") files this request for payment of a 2007 Preauthorized Matching Grant from Cascade Natural Gas Corporation's Preauthorized Matching Fund Account in the amount of \$6,589.17. This request for payment is filed pursuant to the Stipulation adopted by the Oregon Public Utility Commission ("OPUC") in Order No. 07-221 and Section 7.2 of the Intervenor Funding Agreement ("IFA"), which was approved by the OPUC on July 2, 2003, in Order No. 03-388. Commitment 35 of the Stipulation provides that Cascade agrees to join the Intervenor Funding Program established by the Commission in Order No. 03-388 beginning in calendar year 2007 under the same terms and conditions as the other utilities participating in the programs, with the exception that Cascade will make available \$30,000 in each of the three accounts. The Commission's rules provide that the terms of a Commission-approved intervenor funding agreement will be binding on all organizations seeking a grant under the agreement and will be followed by the Commission in administering the agreement. OAR 860-012-0100(2).

NWIGU meets all of the criteria for payment of a Preauthorized Matching Grant from the Cascade Preauthorized Matching Fund Account, as demonstrated by the following:

1. Under the IFA, Cascade makes available an Annual Grant Amount of \$30,000 in 2007 for Cascade's Preauthorized Matching Fund Account. IFA at Section 4.2.2. NWIGU has not made a Request for Payment for a Preauthorized Matching Grant for Eligible Expenses incurred in 2007. NWIGU may file a Request for Payment for a Preauthorized Matching Grant at any time during the term of the IFA. IFA at Section 7.2. The current IFA does not expire until December 31, 2007, with the First Amended and Restated Intervenor Funding Agreement becoming effective on January 1, 2008 under Order No. 07-564 until December 31, 2012. Funds from Cascade's Preauthorized Matching Fund Account are available for use exclusively by NWIGU, IFA at Section 4.2.2.
2. A Preauthorized Matching Grant from Cascade must be used solely to pay Eligible Expenses for Eligible Proceedings involving Cascade. IFA at Section 4.2.2. NWIGU requests the payment of a Preauthorized Matching Grant for Eligible Expenses incurred in the following Eligible Proceedings in 2007 through August 31, 2007: UG 173 and UM 1283. NWIGU requests the payment of the \$6,589.17 Preauthorized Matching Grant for the expenses listed in Exhibit A, attached, which are Eligible Expenses under Section 7.4 of the IFA. These expenses are in excess of any amounts recovered through Issue Fund Grants and/or other Matching Fund Grant Requests.
3. A Preauthorized Matching Grant may be provided only if NWIGU demonstrates that it has used in-house resources or outside funding for at least 50% of the Eligible Expenses for Eligible Proceedings. IFA at Section 7.2. As shown in Exhibit A, NWIGU has used in-house resources and outside funding for at least 50% of the Eligible Expenses in each of these proceedings.
4. Section 4.2.2 of the IFA requires that NWIGU become precertified (in accordance with Section 5.2 of the IFA) within one year of the effective date of the IFA in order to be eligible to receive a Preauthorized Matching Grant. NWIGU became precertified as eligible to receive intervenor funding grants under Section 5.2 of the IFA pursuant to Order No.04-055, entered by the Commission on February 3, 2004.

Having demonstrated that it meets all of the criteria and conditions for such request, NWIGU requests payment of a Preauthorized Matching Grant from Cascade's Preauthorized Matching Fund in the amount of \$6,589.17. NWIGU requests that the Commission grant this request within 30 days of receipt and order Cascade to pay NWIGU the amount of \$6,589.17 within 30 days after receipt of the Commission directive, in accordance with Section 7.2 of the IFA.
