1. Maury Galbraith, Staff. PGE plans to cross examine Mr. Galbraith regarding Staff’s proposed disallowance of costs incurred by PGE in purchasing power to serve customers. PGE estimates that it will cross-examine Mr. Galbraith for one hour.
2. Randy Falkenberg, ICNU. PGE plans to cross-examine Mr. Falkenberg about ICNU’s proposed power cost adjustment and also regarding his testimony regarding load forecasting. PGE estimates it will cross-examine Mr. Falkenberg for ninety minutes.
3. Bob Jenks, CUB. PGE plans to cross-examine Mr. Jenks about the issues he raised in his testimony, including CUB’s proposed adjustment to PGE’s power costs. PGE expects to cross-examine Mr. Jenks for fifteen minutes.
