**PACIFICORP'S MOTION FOR
SCHEDULE CHANGES
(Expedited Consideration Requested)**

On March 11, 2005, the Commission issued a Notice of Hearing in Docket UM 1147, scheduling oral argument for Monday, April 4, 2005 at 9:00 am. Because this hearing date is only one business day before the commencement of settlement discussions in UE 170, two business days before the filing of issue lists in UM 1056/UM 1182 and two business days after PacifiCorp's summary judgment motion is due in UE 171, PacifiCorp needs a short setover of the oral argument to allow adequate time for preparation for the argument.

PacifiCorp understands from the ALJ that the only alternative hearing date available for the UM 1147 oral argument is Monday, April 11, 2005. Because this date conflicts with settlement conferences in UE 170, this setover requires a change in the UE 170 settlement conference schedule from all day on April 11, 2005 to the afternoon of April 11, 2005. To ensure that adequate time remains available for settlement discussions, PacifiCorp proposes that UE 170 settlement conferences continue through April 12, 2005. PacifiCorp understands that a full day of settlement discussions may not be necessary on April 12, but asks that the full day be reserved to provide flexibility to the schedule.

Thus, PacifiCorp seeks the following schedule changes in UM 1147 and UE 170:

1. A reset of the oral argument in UM 1147 from 9:00 am on Monday, April 4, 2005 to 9:00 am on Monday, April 11, 2005;
2. A change in the settlement conference scheduled in UE 170 on Monday, April 11, 2005 from all day to a start time of 1:30 pm; and

1 3. A change in the settlement conference schedule in UE 170 to add Tuesday, April
2 12, 2005 as an additional settlement day.

3 Staff, ICNU, and CUB have no objections to this request. PacifiCorp called Fred
4 Meyer Stores but has not heard back; because of the need to get this motion on file as soon as
5 possible, PacifiCorp did not have an opportunity to canvass other parties to these two
6 dockets.

7 PacifiCorp requests that the Commission consider this motion in an expedited
8 manner.


