Pursuant to OAR 860-013-0031 and 860-014-0010, Portland General Electric ("PGE") moves the Oregon Public Utility Commission ("Commission") to amend the schedule in this docket as outlined below. In support of this motion PGE states:

1. Pursuant to the schedule set in this matter Commission Staff ("Staff"), and intervenors Citizens' Utility Board ("CUB") and Industrial Customers of Northwest Utilities ("ICNU") recently filed testimony. ICNU desires to respond to the testimony of Staff; however, the current schedule does not afford ICNU that opportunity. In addition, PGE desires additional time to prepare its rebuttal testimony. Some parties have also indicated that, depending on the content of PGE Rebuttal Testimony, they may seek to add additional rounds of testimony and/or change the hearing date previously set. To accommodate those concerns, counsel for PGE, Staff, CUB and ICNU have agreed to the following modification to the schedule in this matter:

2. For the reasons stated above, PGE requests that the schedule in this proceeding be modified as set forth above. No request is made to alter the scheduled hearing date at this time.

3. All parties to this docket agree to the proposed revised schedule, and PGE respectfully requests that the Administrative Law Judge consider this motion on an expedited basis prior to March 15, 2005, the filing date currently set for PGE's rebuttal testimony.
