

III.

XO has a direct and material interest in the issues raised in this proceeding. XO is a competitive telecommunications provider certified to provide service in the state of Oregon. XO also purchases and may purchase in the future unbundled network elements (“UNEs”) from Qwest in Oregon. In this proceeding, Qwest has asked to deregulate certain Qwest services on the basis of UNE-based competition from providers such as XO. The Commission granted XO’s initial Petition to Intervene, but XO subsequently withdrew from this proceeding. In light of subsequent events, including issues arising from Staff’s Survey Results and implementation of the Federal Communications Commission’s Triennial Review Remand Order, XO again seeks to be a party to this proceeding. Accordingly, XO has an interest in this proceeding.

IV.

XO will address such issues as it deems relevant in this proceeding, including all issues relevant to competitive providers of telecommunications services in Oregon.

XO has knowledge and expertise that will assist the Commission and the parties in addressing the issues presented in this proceeding.


