DISPOSITION: MODIFIED SCHEDULE ADOPTED

A prehearing conference was held by telephone in this docket on March 9, 2005. Qwest Corporation (Qwest); Integra Telecom of Oregon, Inc.; the Telecommunications Ratepayers Association for Cost-Based and Equitable Rates; Time-Warner Telecom; Rio Communications; NoaNet Oregon and Oregon Telecom, Inc. (Joint Commenters); Covad Communications Company (Covad); and the Commission staff (Staff) entered appearances at the conference.

The parties indicated that they had reached agreement with respect to the timing of the CLEC survey and the tracking of Qwest Platform Plus (QPP) rather than UNE-P data. The survey issue regarding inclusion of Voice over Internet Protocol (VoIP) was not resolved. Staff and Covad indicated that they did not wish to comment further on the issue; Qwest was granted until March 11, 2005, to file reply comments to Covad's objections. The Administrative Law Judge (ALJ) indicated that he would rule on the question and issue the appropriate bench request by March 15, 2005, according to the agreed-upon schedule.

The ALJ adopted the schedule, affixed hereto as Appendix A.
