This Amendment No. 1 to the Wireless Interconnection Agreement (“Agreement”) entered into on the fifteenth day of March 2002, by and between TDS Telecommunications Corporation as agent for Home Telephone Company, Inc. and Asotin Telephone Company, each of which is an Oregon corporation and Incumbent Local Exchange Carrier, (“TDS TELECOM”) and Cellco Partnership d/b/a Verizon Wireless on behalf of the FCC CMRS licenses listed on Appendix B of the Agreement (“VZW”), referred to individually as “Party” and collectively as “Parties”, is entered into this twelfth day of December 2008.

WHEREAS, as provided herein, the Parties wish to amend the Agreement.

NOW THEREFORE, in consideration of the mutual promises and upon the terms and conditions set forth below, the Parties agree:


Pursuant to **Section Appendix B, FCC and CMRS Licensees and Markets**, the following Licensed Entities are added:
