Dear Sir or Madam:


I submit this request on behalf of OrbitCom, Inc. On April 29, 2015 Ionex Communications North, Inc. d/b/a Birch Communications (“Ionex”) and OrbitCom notified the Commission of a pending transaction pursuant to which OrbitCom would transfer substantially all of its telecommunications assets and Oregon customer base to Ionex. In accordance with OAR 860-032-0020(11), Ionex and OrbitCom requested a waiver of the rule requiring a provider to give 90 days’ notice of the impending transfer to the affected customers. On May 19, 2015, pursuant to Order No. 15-154, this Commission waived the customer notification periods associated with the transfer of assets. The customer notice was mailed to all impacted customers shortly thereafter. On July 8, 2015, counsel for Ionex provided notice to this Commission that the transfer of assets has now been consummated.

As a result of the transfer, OrbitCom no longer has customers in Oregon nor will it provide telecommunications services in Oregon. Accordingly, pursuant to the relevant provisions of OAR 860-032 *et seq.*, OrbitCom respectfully requests cancellation of the certificate of authority it was granted on October 20, 2004, as well as cancellation of any related filings. See Docket No. CP 1254, Order No. 04-618.
