We have received your request that, in accordance with Section 252(i) of the Federal Telecommunications Act of 1996, Southwestern Bell Communications Services aka SBC Long Distance, ("SBC-LD") wishes to enter into Qwest Corporation's Statement of Generally Available Terms ("SGAT") and Exhibits A through M for the State of Oregon.
