The Citizens Utility Board of Oregon (CUB) files this Notice of Intent to Request an Issue Fund Grant in UM 1182, pursuant to OAR 860-012-0100 and the First Amended and Restated Intervenor Funding Agreement (IFA), approved by the Oregon Public Utility Commission (Commission) in Order No. 07-576 (December 20, 2007).

1. The Commission, pursuant to Order No. 11-001, has reopened Docket No. UM 1182 to address concerns about self-build bias and to further examine issues related to the competitive bidding guidelines. The Commission will examine this filing in this second phase of Docket No. UM 1182.
2. UM 1182 is an Eligible Proceeding under the IFA. The IFA defines an Eligible Proceeding as “any Commission proceeding that directly affects one or more of the Participating public Utilities.” IFA, Section 1(c).
3. UM 1182 will directly affect PacifiCorp, Portland General Electric, and Idaho Power which are Participating Public Utilities under Section 1(k) of the IFA.

4. As required by IFA Section 6.2, this Notice of Intent is being served on each affected Participating Public Utility, all precertified organizations, and all parties identified on the service list from UM 1182.
5. CUB identifies the following Issue Fund Accounts as those from which CUB intends to request Issue Fund Grants: The 2011 PacifiCorp Issue Fund Account, the 2011 Portland General Electric Issue Fund Account, and the 2011 Idaho Power Issue Fund Account.
6. CUB has been precertified under Section 5.2(a) of the IFA and OAR 860-012-0100(3)(a), as eligible to receive an Issue Fund Grant.
7. CUB will file proposed budgets with respect to each Issue Fund Grant, as provided in Section 6.3 of the IFA.
