On May 16, 2005, I wrote to you to report the status of the parties' negotiations in Docket No. UM 1198. As I noted in that letter, the parties have reached an agreement resolving all issues in the docket, and are currently working to reduce that agreement to writing. I reported on May 16, 2005, that the parties would be prepared to file the Stipulation and supporting testimony by June 10, 2005. In fact, the parties need additional time to prepare the Stipulation and supporting testimony.
