MOTION TO AMEND SCHEDULE

9 The Public Utility Commission of Oregon Staff (“Staff”) respectfully requests that the  
10 filing and hearing dates established by the September 2, and September 29, 2005, Rulings be  
11 modified. Under the current schedule Staff and Intervenors’ supplemental testimony is due on  
12 October 5, 2005, PacifiCorp’s response is due on October 12, 2005, and the hearing is  
13 scheduled on October 26, 2005. Staff requests that the schedule be changed to provide for Staff  
14 and Intervenors to file their supplemental testimony on October 17, 2005, with PacifiCorp’s  
15 response due on October 31, 2005. Staff also requests that the hearing be scheduled on  
16 November 16, 2005. Staff has contacted PacifiCorp, ICNU, and CUB about this motion. None  
17 of these parties oppose this request.

18 Staff responsibilities in other dockets have prevented Staff from meeting the current  
19 schedule. Staff witnesses Maury Galbraith has major responsibilities in UM 1182, UM 1056,  
20 and UM 1209. Staff is filing testimony in UM 1182 and UM 1056 today. As a result, Mr.  
21 Galbraith has not been able to devote the time necessary to complete his testimony by October 5,  
22 2005.
