Pursuant to OAR §860-013-0031, PacifiCorp (or the "Company") respectfully moves that the proceedings in the above-referenced docket be stayed and that the Commission refrain from issuing its order in this docket for sixty (60) days.

DISCUSSION

On April 15, 2005, PacifiCorp filed its Application in this docket, to establish a power-cost adjustment mechanism ("PCAM"). Since that time, the docket has proceeded accordingly. On January 27, 2006, the parties filed closing briefs, and they are now awaiting the Commission's final order.

During the interim, PacifiCorp has experienced a recent change of ownership and is now part of the MidAmerican Energy Holdings Company family. In addition, PacifiCorp has had the opportunity to discuss possible resolution of this and other matters and would like some additional time in order to further those efforts and discuss such issues with other interested parties. It is PacifiCorp's belief that granting a sixty (60) day stay of this proceeding will cause no harm, and will not prejudice the interest of any party to this proceeding.

CONCLUSION

For the foregoing reasons, PacifiCorp's request, that the Commission stay the proceedings and refrain from issuing an order in this docket for sixty (60) days, should be granted.
