Re: CP 1283 -- Application of LS Networks for Certificate of Authority

Dear Ms. Hari:

On April 20, 2005, Lightspeed Networks, Inc. (d/b/a "LS Networks") filed an Application for a Certificate of Authority to Provide Telecommunications Service in Oregon and Classification as a Competitive Telecommunications Provider ("Application") with the Oregon Public Utilities Commission. LS Networks recently learned that information regarding affiliated interests was inadvertently omitted from its Application and would like to amend Section 4. Section 4, titled "Affiliated Interests", asks whether the applicant is currently or has ever been "affiliated with any provider of telecommunications service that serves Oregon? If so, who? When? Describe affiliation." LS Networks initially responded "No" and would now like to amend that response to say the following:

Yes. The following companies have been shareholders in LS Networks since its formation: 1) Central Electric Cooperative, Inc. (the sole owner of CEC Resources, Inc., which is the sole owner of Quantum Communications, LLC, Certificate No. 7884, OPUC Docket No. CP 924); 2) Douglas Electric Cooperative, Inc. (the sole owner of Douglas Services, Inc., Certificate No. 7915, OPUC Docket No. CP 962); 3) West Oregon Electric Cooperative, Inc. (the sole owner of Western Oregon Services, Inc., which is the sole owner of Columbia Broadband, Inc., Certificate No. 8068, OPUC Docket No. CP 1095); 4) Tribal One Broadband, Certificate No. 7971, OPUC Docket No. CP 998; 5) Rural Services Company, Certificate No. 8123, OPUC Docket No. CP 1153; and 6) Hood River Electric Cooperative, Certificate No. 7923, OPUC Docket No. CP 971.
