QWEST'S CLARIFICATION IN  
RESPONSE TO ALJ RULING OF MAY  
25, 2006

Pursuant to Administrative Law Judge Christina Smith's May 25, 2006 Ruling pertaining to Qwest's petition for a waiver of customer notification provisions for certain customers arising from the Commission's approval of the EAS petitions in these dockets, Qwest responds as follows:

Staff and Qwest held additional conversations after Qwest's initial May 15, 2006 petition for waiver. Consistent with Staff's concurrence, any Qwest customers receiving new EAS routes and a rate increase will receive from Qwest a notification consistent with Order Nos. 06-198 and 06-226. Qwest is also in agreement with Staff that any Qwest customer that is receiving new EAS routes and no concomitant change in rates can be notified through a message on the customers' telephone bill or an insert to the customers' bill.
