**PACIFICORP'S NOTICE OF
WITHDRAWAL OF AMENDED
REQUEST FOR ACKNOWLEDGMENT
OF FINAL SHORTLIST OF BIDDERS
IN 2012 REQUEST FOR PROPOSAL**

PacifiCorp d/b/a Pacific Power ("PacifiCorp" or "Company") respectfully submits this notice of withdrawal of its Amended Request for Acknowledgement of Final Shortlist of Bidders in 2012 Request for Proposals ("Amended Request"). The Company originally filed a request for acknowledgment of its final shortlist, comprised of two bidders on December 4, 2008. On December 17, 2008, PacifiCorp filed its Amended Request to remove one of the resources from its final shortlist. Parties filed comments on the Amended Request on February 9, 2009 and a special public meeting was held before the Public Utility Commission of Oregon ("Commission") on February 10, 2009 to address the request.


Given the dramatic global economic downturn in late 2008 and the resulting reduction of customer loads, reduction in price of commodities and potential reduction of future construction costs, the Company has determined to further explore resource alternatives. To that end, PacifiCorp delivered a formal written termination notice to each of Summit Vineyard, LLC and CH2M HILL E&C, Inc. on February 11, 2009, thereby terminating the Master Development, Engineering, Procurement and Construction Agreement, dated as of November 26, 2008 (the "Agreement"). PacifiCorp filed notice of termination of the Agreement with the Commission on February 12, 2009. Pursuant to the

terms of the Agreement, the termination of the Agreement became effective five business days after delivery of the written notice of termination, or February 18, 2009.

The Company remains committed to securing viable, cost effective resources to meet its forecasted needs for summer 2012.

Accordingly, PacifiCorp respectfully withdraws its Amended Request from further consideration and requests that the Commission close this docket.


