Attached hereto as Exhibit A is a Certificate of Good Standing from the Utah Supreme Court.


2. I am not subject to any pending disciplinary proceedings in any jurisdiction.

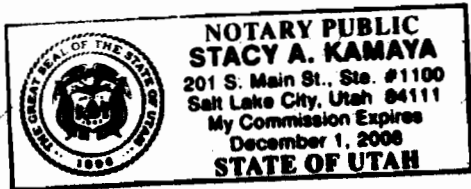

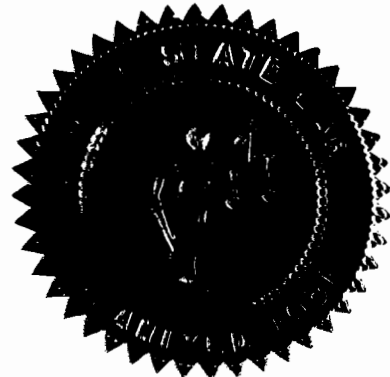
