On March 17, 2006, Richard A. Finnigan, counsel for the Oregon Telecommunications Association ("OTA") submitted a letter objecting to the admission of Exhibit RCC-USCC/14 as lacking foundation. Mr. Finnigan indicated that he would withdraw his objection if certain pages from the transcript in Docket No. UM 1083 were also included as part of the exhibit. To address Mr. Finnigan's objection, US Cellular Corporation is submitting all of the pages of the UM 1083 transcript that discuss Exhibit RCC-USCC/14. These pages are from the December 16, 2003 hearing and include pages 56, line 13, through 58, line 13; pages 79, line 8 through the end of page 110; and pages 118, line 16 through 120, line 19; and pages 124, line 1 through 127, line 16. Because these pages were downloaded from an electronic copy of the transcript, the correct page numbers are embedded in the text and are not the numbers noted at the bottom of the pages.


