UM 1217: OTA's Objection to the Admission of Exhibit RCC-USCC/14

On March 17, 2006, Richard A. Finnigan, counsel for the Oregon Telecommunications Association ("OTA") submitted a letter objecting to the admission of Exhibit RCC-USCC/14 as lacking foundation. Mr. Finnigan indicated that he would withdraw his objection if certain pages from the transcript in Docket No. UM 1083 were also included as part of the exhibit. To address Mr. Finnigan's objection, US Cellular Corporation is submitting all of the pages of the UM 1083 transcript that discuss Exhibit RCC-USCC/14.
