MOTION TO MODIFY SCHEDULE

8 Staff of the Public Utility Commission of Oregon asks the administrative law judge
9 (ALJ) to modify three dates in the procedural schedule in the above-captioned docket.¹ Pursuant
10 to the current schedule, staff and intervenor changes to Portland General Electric Company's
11 ("PGE") depreciation study are due June 19, 2006. The schedule also calls for a settlement
12 conference on July 7, 2006 and for the parties to distribute an Issues and Agreement list on July
13 14th. Staff requests that that the ALJ modify the procedural schedule as follows:

19 Staff asks for the schedule modification because it needs additional time in which to
20 finalize its proposed changes PGE's depreciation study.

21 The other parties to this docket, PGE and the Citizens' Utility Board have been consulted
22 regarding this request for schedule change and neither objects. Notably, the modification to the
23 date for settlement conference does not require the ALJ's authorization. However, staff includes


