of its Telecommunications Authorization

Dear Ms. Beier:

Nextlink Wireless, LLC (Nextlink or Company) respectfully requests that the Public Utilities Commission (Commission) cancel Nextlink's certificate to provide facilities-based and resold switched and non-switched local exchange and interexchange services in Oregon.

The Commission granted Nextlink a certificate to provide facilities-based and resold switched and non-switched intraexchange and interexchange services in Oregon on March 12, 2006 in Docket No. CP 1313.<sup>1</sup> The Company subsequently determined that its strategic business plans do not include the provision of facilities-based and resold switched and non-switched local exchange and interexchange services. Nextlink has no customers in Oregon for facilities-based and resold switched and non-switched local exchange and interexchange services. Accordingly, there are no customers to be notified regarding this request, and cancellation of Nextlink's certificate will have no adverse consequences for consumers in Oregon.

Nextlink understands that formal approval from the Commission is not required in order for the Company to surrender its certificate. If the Commission nonetheless determines that


