Portland General Electric Company (“PGE”) requests that the Administrative Law Judge modify the procedural schedule in this docket. This motion is supported by the other parties in this docket: Staff of the Public Utility Commission, the Citizens’ Utility Board, and the Industrial Customers of Northwest Utilities (collectively the “Parties”).

On March 4, 2010, the Administrative Law Judge issued a Prehearing Conference Report that set a schedule for this docket. Shortly thereafter the Parties were involved in the prehearing conference to set a schedule in docket UE 215, PGE’s recently filed general rate case. Some of the Parties also needed to accommodate the schedule for PacifiCorp’s recently filed general rate case, docket UE 217. Both of those dockets have statutory time limits for their completion and significant procedural requirements. The Parties agreed to seek a change in the schedule in this docket, UM 1252, to avoid, to the extent possible, conflicts with those other schedules. The Parties have conferred and agreed on the proposed schedule set forth below for the remainder of this docket. Accordingly PGE requests that the Administrative Law Judge modify the schedule in this docket as follows:

Hearings Begin	Wednesday, September 8, 2010


Dates for briefing and oral argument, if needed, will be determined by the hearing date.

The final paragraph of the March 4, 2010, Prehearing Conference report directed that there will be a seven business day turnaround for discovery requests after the due date for PGE's Rebuttal Testimony. That paragraph also addressed the timely service of confidential and non-confidential material. The Parties do not request any change to the deadlines set forth in that paragraph.

For the foregoing reasons PGE asks the Administrative Law Judge to amend the procedural schedule in this docket as set forth above.
