Dear Judge Grant:

The Commission issued Order No. 06-299 in the above-referenced proceeding on June 14, 2006, pursuant to ORS 756.515(4). On June 30, 2006, Harbinger Capital Partners Master Fund I, Ltd. ("Harbinger") filed a request that the Commission hold a hearing to determine whether that order should continue in effect, pursuant to ORS 756.515(5). ORS 756.515(5) provides that the Commission shall hold the hearing not later than 60 days after receipt of such a request.

As you may know, the parties to this proceeding have been negotiating a potential resolution that may obviate the need for a hearing. August 29, 2006 is the 60<sup>th</sup> day following Harbinger's request for a hearing. In view of this impending date, Staff asked Harbinger if it would agree to waive the statutory requirement that the Commission hold a hearing within 60 days of Harbinger's request.

I am writing to inform the Commission that Harbinger will not object if the hearing requested in this matter is convened after the statutory 60-day period, subject to the following two conditions. First, Harbinger reserves the right to request a prompt hearing before the Commission in this matter, and agrees to waive the 60-day requirement on the condition that the Commission will convene a hearing no later than 60 days after Harbinger makes a written request therefor. Second, Harbinger

will agree to waive the 60-day requirement upon the condition that the Commission will not convene a hearing with less than 30 days' notice to Harbinger.
