On January 16, 2009, the Public Utility Commission of Oregon (Commission) received an Application for Allocation of Exclusive Service Territory from PacifiCorp, dba Pacific Power. A general description of the area related to this proposal, is as follows:

AREA B-5

Beginning at the west quarter corner of Sec. 25, T. 1 N., R. 17 E., Willamette Meridian; thence east to the east quarter corner of said Sec. 25; thence south to the southeast corner of said Sec. 25; thence east to the northeast corner of Sec. 31, T. 1 N., R. 18 E.; Thence East along the section line for one mile to the NE corner of section 32, T. 1N., R. 18 E., thence South to the west one quarter corner of section 33, T. 1N., R. 18 E.; thence East for eight miles along the midsection line to the East one quarter corner of section 34, T. 1 N., R.19 E.; thence South to the SE corner of section 34, T. 1 N., R. 19 E.; thence West along the section line to a point 660' East of the SW corner of said section 34; Thence South to East-West centerline of section 3, T. 1 S., R. 19 E.; thence West along the midsection line to the center of section 6,T. 1 S., R. 18 E.; thence North to the North quarter corner of said section 6; thence west to the west line of the east half of the east half of Sec. 1, T. 1 S., R. 17 E.; thence south to the north line of the south half of the south half of said Sec. 1; thence west to the west line of said Sec. 1; thence south to the southwest corner of said Sec. 1; thence west to the southwest corner of Sec. 2, T. 1 S., R. 17 E.; thence north to the northwest corner of said Sec. 2; thence east along the Township line to the east line of the west half of the west half of Sec. 35, T. 1 N., R. 17 E.; thence north to the east-west center line of said Sec. 35;

thence east to the west line of the east half of the east half of said Sec. 35; thence north to the north line of said Sec. 35; thence east to the southwest corner of Sec. 25, T. 1 N., R. 17 E.; thence north to the west quarter corner of said Sec. 25, in T. 1 N., R. 17 E., W. M., the point of beginning of Area B-5.

More detailed description and additional information may be obtained from Pacific Power or the Public Utility Commission of Oregon.

Any affected party or customer may request a hearing on this matter within 30 days of the second and final publication date of this notice. The final publication date is February 8, 2009. The Commission will, within 30 days of such request, set the time and place of a hearing. The hearing will produce the record from which the Commission will determine whether or not the territory will be allocated.
