Dear Ms. Shepherd:

On May 18, 2017, Radiate HoldCo, LLC, a Delaware limited liability company and an indirect wholly-owned subsidiary of Radiate Holdings, L.P. (“Radiate”), entered into an agreement to acquire all the outstanding membership interests of Wave Holdco, LLC (“Wave”) and its subsidiaries, including Astound Broadband, LLC (“Astound”), which currently holds a Certificate of Authority to offer service in the state of Oregon (ID No. 8466), from the holders thereof (the “Transaction”). The Transaction offers tremendous prospects for continued enhancements to the system and services available to telecommunications customers in Oregon.

When the Transaction is consummated, the indirect control of Astound will change from Wave to Radiate, but Astound’s legal name and its status as a company duly registered to do business in Oregon will not change and Astound will continue to provide service pursuant to its Certificate. Radiate has no current plans to change the local operations or structure of Wave’s and Astound’s Oregon operations, or the services offered by Wave and Astound. Radiate plans to combine its resources and expertise with Wave’s and Astound’s knowledge of the Oregon telecommunications marketplace to build upon the success of Radiate and further enhance the experience for Oregon customers.


You do not need to take any action in response to this letter. Under OAR 860-027-0025, this notice satisfies all state requirements related to transfer of the Certificate of Authority.^{1/} Radiate and Wave have filed an application with the Federal Communications Commission (“FCC”) for approval of the transfer of control and the FCC is currently reviewing the application. The parties intend to close following receipt of required regulatory approvals.


