- 3. If the petitioner is an organization, the number of members in and the purposes of the organization: The Northern California Council, Federation of Fly Fishers is made up of 30 member clubs from Fresno in the south to the Oregon border. We have approximately 4,000 members. We are a fishing organization focused on the sport of fly fishing. We teach fly casting, fly tying and fishing techniques with fly equipment. We also are very supportive of conservation work that benefits the fisheries of our area, including the famous Klamath River, where many of our members fish and camp. It is a historical fishing river for the fly fishing community.
- 4. The nature and extent of the Petitioners' interests in the proceeding are: The Klamath River is a fishing location like few others in California and Oregon. The fly fishing community has long fished this river system, and values it like few others in the west. My organization has great interest in the river for its fishing, camping, watershed beauty and history of one of the great fishing rivers of the western U.S. We are interested in completing the Klamath Hydropower Settlement Agreement, which we have worked on for the past 6 years. We feel strongly that this agreement in conjunction with the Klamath Basin Restoration Agreement will provide the foundation for a return to the historical fish producing river the great Klamath River once was.
 - 5. The issues the Petitioner intends to raise at the proceeding are:
 In general, we support the full and equitable implementation of SB 76 and the goals of the KHSA, the funding mechanism for which is embodied SB 76.
 - 6. The special knowledge or expertise of the Petitioners that would assist the Commission in resolving the issues of the proceeding is:
 - NCCFFF has been a key stakeholder representatives in the negotiations which led to the Klamath Hydroelectric Settlement Agreement (KHSA) since they began in 2000, are signatory Parties to the KHSA, and are familiar with every aspect of that Agreement. Since many of our individual members are also PacifiCorp ratepayers in northern California and coastal Oregon, we also have some expertise on how SB 76 and the KHSA will affect those customers.
 - 7. Based on the information provided above in accordance with the Commission's rules of procedure, we request to participate in this proceeding as interveners. I or the organizations I represent will not unreasonably broaden the issues, burden the record, or unreasonably delay the proceeding, in accordance with OAR 860-012-0001.
