Re: i-wireless, LLC (UM 1509) Proposed Changes to Lifeline Offering

To Whom It May Concern:

Pursuant to paragraph 21 of the Stipulation adopted by the Commission in Order No. 15-300, i-wireless, LLC d/b/a Access Wireless (“i-wireless” or the “Company”) hereby submits proposed changes to its Lifeline offering as described in the attached Exhibit D, which replaces Exhibit D of the Stipulation and any previous revisions thereto.

Beginning as early as March 16, 2020 if permitted, new customers will receive 750 voice minutes, unlimited text, and 3 gigabytes (GB) of data (the updated Oregon Broadband & OTAP Plan). Customers currently on the Oregon Broadband & OTAP Plan will begin receiving the increased benefits as of their next billing cycle after the plan changes become effective.

The proposed changes do not reflect a reduction in benefits or increase in price and are therefore able to take effect ten (10) days from the date of this filing. However, given that the changes result in either no change or increased benefits to the consumer, the Company respectfully requests an effective date of March 16, 2020.
