Re: i-wireless, LLC (UM 1509) Proposed Changes to Lifeline Offering

To Whom It May Concern:

Pursuant to the Public Utility Commission of Oregon's ("Commission") temporary rule amendments outlined in Docket No. AR 634 ("Temporary Rule Amendments"), i-wireless, LLC d/b/a Access Wireless ("Access Wireless" or the "Company") implemented a temporary rate plan effective July 1, 2020 through December 31, 2020 (or upon expiration of the Temporary Rule Amendments) offering unlimited voice minutes and unlimited data at no charge to Lifeline customers in exchange for Oregon Telephone Assistance Program ("OTAP") support of \$12.00 per month.

Pursuant to paragraph 21 of the Stipulation adopted by the Commission in Order No. 15-300, Access Wireless hereby submits proposed changes to its Lifeline offering as described in the attached Exhibit D, which replaces Exhibit D of the Stipulation and any previous revisions thereto. The changes described in Exhibit D do not reflect a reduction in benefits or increase in price and are therefore able to take effect ten (10) days from the date of this filing. The changes do not affect the temporary OTAP plan, but rather the plan to which customers will revert once the Temporary Rule Amendments expire.
