Due to changes in the Federal Communications Commission's ("FCC") minimum service standards that will take effect December 1, 2017, and pursuant to paragraph 21 of the Stipulation adopted by the Commission in Order No. 15-300, i-wireless, LLC d/b/a Access Wireless ("i-wireless" or the "Company") hereby submits proposed changes to its Lifeline offering, as described in the attached Exhibit D, which is intended to replace Exhibit D of the Stipulation and any previous revisions thereto.

The changes to Access Wireless Lifeline plans described in Exhibit D reflect an increase in benefits to the consumer, and are therefore able to take effect ten (10) days from the date of this filing, consistent with paragraph 21 of the Stipulation. The "Legacy" plan will become effective on December 1, 2017. The Oregon Lifeline & OTAP and Oregon Broadband & OTAP plans will be available beginning February 1, 2018. i-wireless also proposes to remove the retail plan offers, as noted in the Company's October 12, 2016 filing in this docket, as they are no longer competitive with the Access Wireless Lifeline plans with corresponding top-ups.
