Pursuant to OAR 860-013-0031, Portland General Electric (“PGE”) requests that the schedule set in this docket be suspended. PGE, Staff of the Public Utility Commission (“Staff”), and the Citizens’ Utility Board (“CUB”) (collectively the “Settling Parties”), have reached a settlement in principle of all issues in this docket. Industrial Customers of Northwest Utilities (“ICNU”) has indicated it may oppose part of the settlement. The Settling Parties are in the process of drafting a Stipulation and supporting joint testimony to be submitted to the Commission.

Under the current schedule in this docket, PGE testimony is due March 15, 2011. Subsequent dates for staff and intervenor testimony, PGE reply testimony and a hearing are also set. PGE, with the support of the other Settling Parties, requests that these deadlines be suspended. The Parties will endeavor to submit a Stipulation as soon as possible for Commission consideration.


EXPEDITED CONSIDERATION REQUEST
