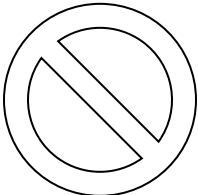

The purpose of this errata is to replace pages 5 and 6 of the above referenced report. On March 29, 2017, Northwest Natural Gas Company, dba NW Natural ("NW Natural" or "Company"), filed the Annual Report of Interstate Storage and Optimization Activities for the year ended December 31, 2016. Subsequent to the filing it was found that the Construction Work in Progress ("CWIP") pertaining to the North Mist Expansion Project ("NMEP") for service to Portland General Electric ("PGE") was incorrectly presented in the December 31, 2016 non-utility CWIP balance. The NMEP investment is the basis of a utility service offered under Rate Schedule 90 and, upon receipt of PGE's Notice to Proceed in 2016, all related CWIP balances were reclassified from non-utility to utility CWIP. Consequently, the non-utility Net Assets presented at December 31, 2016 should have excluded the NMEP expenditures. Please replace the attached sheets in the report filed on March 29, 2017.
