PacifiCorp d/b/a Pacific Power (PacifiCorp) submits for filing the Attestation of Stefan A. Bird regarding the Lake Side 2 natural-gas-fired generating plant (Lake Side 2). This attestation supplements Advice No. 14-008, which was filed on April 11, 2014, and was approved by the Public Utility Commission of Oregon (Commission) at its May 27, 2014 public meeting, provided that the attached attestation is filed by noon on May 30, 2014.

Advice No. 14-008 implements the separate tariff rider for recovery of the revenue requirement associated with PacifiCorp's investment in Lake Side 2, as agreed to in the all-party stipulation in this docket, which the Commission adopted in Order No. 13-474 in docket UE 263.<sup>1</sup> The signed original is being sent by overnight delivery.

In accordance with the all-party stipulation approved in this docket in Order No. 13-474, on April 11, 2014, PacifiCorp d/b/a Pacific Power (PacifiCorp) filed a separate tariff rider to recover the revenue requirement associated with its investment in the Lake Side 2 natural-gas-fired generating plant (Lake Side 2). 
