
Noble Americas Energy Solutions LLC ("Noble Solutions") hereby respectfully moves

AFFIDAVIT OF KEVIN HIGGINS


I, KEVIN HIGGINS, being first duly sworn on oath, depose and say:

2. I filed testimony and associated exhibits (Joint Testimony in Support of Stipulation/100) on behalf of Kroger and Noble Solutions in this matter.

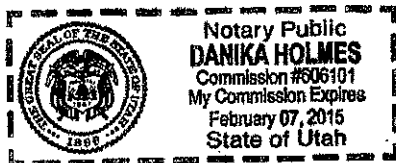
3. To the best of my knowledge, my testimony is true and accurate. If I were asked the same questions today, my answers would be the same.


